#### APPROVAL OF AGENDA:

Board Vice President Gonzales made a motion to approve the agenda for today, May 21, 2024, seconded by board secretary Dr. Meserve. Motion carried 5-0

## NEW BUSINESS: Finance

A. Discussion / Action: 2024-2025 Proposed budget – M. Hillis
Changes in the budget from last Monday include: 5 days of furlough for directors,
reducing the FTE for the associate superintendent, also a reduction of two other FTE,
there were some other minor changes in formula, so the request for emergency
supplemental went from \$2.2 million to \$1.6 million. A meeting is scheduled for
tomorrow with PED, and they are going to inform us how best to proceed for this year and
next year. Motion made not approve budget due to many uncertainties, and PED pending
input, motion to not approve budget passed with a 4-1 vote.

The LVCS Board of Education will officially open up the position of superintendent for the school year 2024-2025, motion made by Mr. Gonzales, Dr. Meserve seconded, passed 3-2 vote.

Second motion to start application process on May 22<sup>nd</sup>, close on June 5<sup>th</sup>, review applicants and conduct interviews on June 7<sup>th</sup>, motion made by Mr. Romero, seconded by Mr. Gonzales, passed 5-0 vote.

Third motion position to be posted: local paper, including the optic, the New Mexican, the Albuquerque Journal, NM Association website, School Board Association website, the Superintendent Association website, and our local cybercardinal website, motion made by Mr. Quintana, seconded by Mr. Gonzales, passed 5-0 vote.
